

LISTEN IN ON THE ACTION!






Spybot is the remote control robot that lets you listen in on the action. With your personal mini-Spybot Controller, maneuver Spybot into position with forward, back-and-turn, or stop commands. Spybot's parabolic reflecting dish and concealed microphone collect voices and sounds, relaying them to you through the Controller. Spybot can help you hear what's happening across the room!

BATTERY INSTALLATION:

Spybot requires one 9-volt transistor battery and four "AA" batteries. To install batteries, remove the battery cover on the back of the Spybot. Insert the 9-volt and four "AA" batteries, making sure the + and - signs match those in the battery compartment.

The mini-Spybot controller requires one 9-volt transistor battery. To install, remove the battery cover on the bottom of the controller and insert the battery as shown. For longer battery life, use Alkaline batteries.



REFLECTING DISH ASSEMBLY:

- Remove the clear plastic reflecting dish from the back of the white foam insert.
- Snap onto the narrow groove in Spybot's neck so the dish is behind Spybot's head, facing forward.

TO OPERATE SPYBOT:

- Move Spybot on-off switch to the "on" position.
- Place Spybot on smooth hard floor or short pile carpet.
- Hold the mini-Spybot controller in an upright position and push the control button on the front of the Controller. Spybot will move forward.
- Release the button and Spybot will stop.
- When Spybot is not moving, sounds will be automatically transmitted from the hidden microphone in Spybot's head through the speaker in the Conroller.
- Push the control button again. Spybot will move backwards and turn until the button is released.
- For best reception, avoid obstacles between Spybot and Controller.
- Always remember to turn Spybot off when not in use.

CARE AND MAINTENANCE:

- Do NOT operate on sand, dirt, or thick carpet. Do NOT allow Spybot or Controller to get wet.
- Do not bend antennae on Spybot or Controller.
- Remove batteries from both units during long periods of non-use.
- Do not store Spybot or Controller in direct sunlight or near hot or cold temperature extremes.
- When speed of Spybot becomes noticeably slower, replace all four "AA" batteries. When maximum range between Spybot and Controller becomes noticeably smaller, replace both 9-volt batteries.

LIMITED WARRANTY:

AXLON, Inc. warrants SPYBOT and the Spybot Controller given normal and reasonable use, to be free from defects in workmanship or materials for 90 days after the original date of purchase.

Except as specified below, Axlon Inc. will repair or at its option replace SPYBOT or the Controller if either unit is defective in material or workmanship during the warranty period at no charge (except as provided herein), provided it is returned to Axlon, Inc.

The Spybot warranty does not cover batteries or damage caused by accident, abuse, or misuse.


